Regatta Committee Representatives are reminded of the Delegates' action, "It will be the duty of each Club Representative to provide a yacht in racing condition of the class designated when he forwards his Club's entry in BBYRA Elimination races for National Cup Events."
2. Encourage your Club to qualify skippers for these competitions.
3. One crew to a Club will be accepted in each of the above categories for the BBYRA Eliminations.
