1. U S Sailing Association.

USCG has approved our Level 1 Dinghy Instructor Training Course, as "recognized as an approved training course" which fulfills the requirements for full USCG licensing for those who wish (or must) pursue this. With even broader application, NASBLA (National Association of State Boating Law Administrators) advised that our boating course (Level 1) meets the standards established by NASBLA. This means that graduates of our courses satisfy the requirements for state licensing in every state that provides for this.

Hurricane Andrew, crashed into the U S Sailing Center in Coconut Grove, FL on August 24th. Packing winds in excess of 160 miles per hour and pushing an eight foot wall of water, the storm flattened the center. Contributions to help restore the center are most welcome, and can be sent to USSF, Box 209, Newport RI 02840 (specify for U S Sailing Center).

- 2. Insurance. All Policies in order.
- 3. U.S.Coast Guard. When 1993 racing schedule is approved, permits will be obtained.
- 4. Appeals. There were two Appeals this year.

REPORT of the SCORER for the 1992 REGATTA SEASON

The 1992 BBYRA Regatta Season has been completed successfully.

The scoring program has continued to provide timely and accurate results for the third year of its use. Those changes recommended by the scorer at the end of the 1991 season and approved by the regatta committee at their winter and spring meetings will be incorporated into the 1993 season program. It should be noted that any changes in scoring that require rewriting of the program will require at least 1 year to be activated in the official program due to the time required to write the code and then test the changes for accuracy.

There was a general increase in the number of boats, registrations and qualifiers in 1992 as compared to 1991.

Of note, the Prindle "18" class qualified only 2 boats and the sub classes L 150 and L Masters both qualified 3 boats and the Laser Radial Jr. qualified 18 boats.

There were 18 protests and 5 appeals for redress filed this season. All have been heard and scored. In addition there were 10 acknowledgements at the finish line.

I would like to thank all of the members of the Regatta Committee for their assistance in recording finishes, accounting for boats in the starting area and for contacting your skippers when needed. In addition I would like to thank the Commodore, Vice Commodore and especially Burton Dezendorf for their help and support during the season.

SUPPLEMENT TO SCORERS REPORT

Several minor problems have arisen, one not directly associated with the final scoring, as well as one that did. Recommendations for their correction follow.

In order to increase the speed and accuracy required for the 10th and final race, it is recommended that both a math co-processor and power line conditioner be purchased. This year extreme power line fluctuations at Seaside Park caused a minor problem in the scoring of one of the classes.

In the future there will be no changes made to the scoring or accountability of boats in the regatta unless the scorer has received a notice of the approved changes in writing prior to the start of the season. This year I was informed verbally of 2 changes that would affect the scoring of various classes one of which also affects the BBYRA financially. I would like both of these to be acted upon again since I can find no reference to them in the minutes of any of the winter meetings that I have received

1:- No sub-class registration will be accepted after the 3rd race. The reason for this is strictly for programming and scoring convenience.

2:- The scoring of cancelled races to be handled as in the past. That is seasonal registrants will be scored since they are already entered as required. Daily registrants will be required to register in order to be scored. However on those occasions morning registrations will be accepted up to 1100 hours. If the afternoon races are also cancelled registrations may be taken up to 1230 hours. It should be noted that this has happened only twice since 1982.

This will follow our sailing instructions section E. paragraph 4. and section C, and is also consistent with IYRU rule 50.

In past years there was a rule that no boat should be scored if her skipper/owner was not a member of the BBYRA following the 2nd race. This was not published this year and generally was not followed until race 8. I believe the rule should be reinstated and enforced.
