NEW BUSINESS

Laser II class requested a 9 race championship season. They would like to omit the conflict with the CORK regatta and Laser II Nationals. Also they would not like to carry a tow line as per the national class. A motion was made to table the Laser II request till the March regatta meeting.

Motion was made and carried to deny the request of the Laser II not to carry a tow line.

A request was made for the Laser Master and 150 to be scored in sub division. A motion was made and passed that the Laser 150, masters, and open Laser to be scored the same way as Laser Radials and all sub groups to be added in total scoring.

A-Cats would like a third place pennaht. A motion was made and denied.

Any class may wish to provide additional trophies at their expense with <u>prior</u> notification to the regatta committee to be awarded at the final awards day. THE INDIVIDUAL CLASS CHAIRMAN SHOULD COORDINATE THIS.

Definition of "Skipper". Wording in rules needs to follow with "or Helmsman" after "skipper". Recommendations to be made at the delegates meeting. Skipper/Helmsman to be added to racing rules.

Hailing according to 8.1 must be provided for in sailing instructions.

BBYRA will not hail pre-mature starters. "X" flag will be given to the line boat and flown from there also.

Motion was made and carried that boats will not be hailed for being over early.

Motion was made and passed that code flag "F" be flown for E Scow floatation. Code flag signals "F" and "Y" indicate floatation for E Scows and Life Jackets to be worn. This was put into a motion and carried.

Motion was made and passed that all junior classes are to wear life jackets at all times.

Motion was made and passed that the age group for the Laser Jr. Radials cannot turn 17 during the calendar year.Sailors shall be 16 years old and younger.

Môtion was made and passed that protests be filed according to USSA 68.6 regarding the time limit.

Motion made and passed to postpone P.M. classes as a block to later starting times. Remove "Note" under P.M. classes on sailing coarse sheet.

Report from Roger Brown to the Regatta Committee, 12/7/91

INSURANCE:

All policies were reviewed with Brouwer Marine Insurance Co. and with Starkweather & Shepley, Inc. The present Policies are in order. It was recommended that we submit an up to date list of items for the Floater Policy and that we obtain ans submit up to date appraisals for our trophy coverage.

UNITED STATES COAST GUARD:

Permits will be requested for the 1992 sailing season when the schedule is approved.

APPEALS COMMITTEE:

There were three Appeals for the 1991 season.

USYRU:

No longer known as "USYRU". We are now UNITED STATES SAILING ASSOCIATION. This is shortened to U.S.SAIL.

It was noted that Sailing Instructors are now required to have a "limited" operator license if they operate power boats. This is commonly known as a "six pack" license.

PHRF sailors note - the Offshore Championship will be held at USNA the first week of November.

It is now mandatory to be a member of U.S.Sail to "Race".

The Rules Committee has been working on an abridged rule book for junions. If completed in time it may be mailed with 1992 Directory.

A new Medical Advisory Committee was formed. This will be a part of the General Services umbrella Committee.

The General Services committee is requesting that all delagates exert maximum effort to obtain support of discounts to members, or mandatory membership status for regattas.

The Championship Long Rage Planning Committee has made several motions. The Sears/Bemis/Smythe Championships be held concurrently every year. The Adams, Mallory and Alter Cups may be held together at a Senio Race Week Championship. Review the Prince of Wales to remain a ladder event for the next two years and then review.

May not recognize as a Ladder Championship the Hinman and O'Day.

Reminding all clubs to review and change reference to USYRU to now read United States Sailing Association or U.S.Sail.

RACING RULES OF THE BARNEGAT BAY YACHT RACING ASSOCIATION

F. PROTESTS, DISQUALIFICATIONS & APPEALS.

- 1. Change USYRU to USSA.
- 2. A party to a protest wishing to appeal a decision of the protest committee shall submit the appeal to the appeal committee of the BBYRA. The appellant shall send a written appeal within 15 days of receiving the protest committee's written decision or its decision not to re-open a hearing. The appellant shall transmit to the appeals committee the dated appeal, which shall include the grounds for the appeal, i.e. why the appellant believes the protest committee's interpretation of the rules to be incorrect, and a copy of the protest committee's decision. Copies of the appeal shall be sent to the Chairman of the Appeals Committee, the Chairman of the Protest Committee, and the Scorer.
- add: 6. The appeals committee prescribes that anyone submitting an appeal shall include payment of \$10.00. [This fee to go to the chairman of the appeals committee to defray expenses.]
