Officer Recommendations to Regatta Committee:

VHF Radio Individual Recalls -

Concern expressed about expense for sailors.

The Officers recommended that "attempt to hail" remain in Sailing Instructions for all classes.

The Officers recommended that E Sloop and Sanderling individual recalls, on a trial basis for 1998, be made on a second VHF channel (competitors' channel)

VHF Radio for Distress and Emergency

Jim Carson's committee to discuss and report back.

Sanderling and A Cat request for a nine race series with class cut on August 15, 1998 so that they could compete at LEHYC -

Harry Foote is to respond to the two fleets that the Officers have recommended that this change not be implemented.

Flying Scot request for a challenger trophy -

Harry Foote is to notify the fleet that the Officers have recommended that a Challenger Fleet Trophy, as a sub fleet trophy, for those not in the top five the previous season and for those not having won a race is acceptable.

E Sloop request for a one day invitational on July 25, 1998 -

The Officers recommend to the Regatta Committee that E Sloop guests be permitted to race on July 25, 1998. They will pay to register, receive lunch, get flags but no perpetual trophies, and be scored for the day but not be included in the BBYRA season scoring. A separate entry form will be used for guests.

A Cat request to race on the Cedar Creek Course the Saturday of the Ocean Gate Regatta and the Saturday of the Seaside Park Regatta -

The Officers do not recommend these changes.

The Sailing Instructions Committee is directed to look into windward/leeward courses and triangular courses.

Other Business:

Patti Applegate is to get a three year contract from Northeast Flags with copies to Anne Attridge and Patti Applegate. If no contract is available, Don McNeil should handle going out for other bids.

New daily entry forms are needed.

Present:

The meeting was called to order by Commodore Hank Waite.

Sailing Instructions Committee Report was made by Jim Carson as follows:

The committee has met and will meet again March 2.

Courses -

Two courses have been changed.

New upper bay courses may be generated for NW winds An insert may be included with the sailing instructions for windward/leeward courses and triangular courses.

Officers suggested including everything on one piece of paper.

Junior Classes (420s, Laser Radials, Blue Jays) Proposal -

If the junior proposal is passed, it is suggested that the junior classes start at the end of the AM and PM sequences (last three classes each).

It was noted by the officers that the junior proposal is meeting with some objections.

If the proposal is rejected, we could offer junior sailors -

Sailing the 10 AMs as usual and offer 5 PMs in addition.

The afternoon sequence may be shortened by eliminating long gaps between classes.

VHF Radios -

Will try individual recalls for E Sloops only unless another class requests same.

Safety issue will be addressed at a later time.

The Scorer has suggested the following:

The check in system should be more complete and comprehensive.

Officers felt this is not a big problem and that accountability has been well handled.

The 40%, 60%, and 80% penalties should be eliminated.

The officers agreed.

Class Eligibility Committee Report was made by Jim Carson as follows:

All 1997 classes have qualified to sail in 1998.

No new classes have petitioned to compete.

The Flying Scot Class has requested a sub group category.

The committee will propose full status for the 420 Class with the following age limits:

The skipper - 21 years and younger; cannot turn 22 during calendar year. The crew's age unlimited.

The Midget Finals will be held August 20 and 21 at Monmouth Boat Club.

Individual Members

It was suggested that a blurb about what's new in the BBYRA be included with the decals and membership cards.

Agendas

The officers reviewed agendas for Regatta, Executive, and Delegates Meetings. Changes were made and a decision was made to "vote as we go".

Information Sheets

Betty Jane France will redo information sheets for 1999 to include both summer and winter addresses and phone numbers plus person from each member club who should receive Individual Membership information and assume responsibility for returning lists and monies to BBYRA Membership Chairperson.

Ocean County Department of Public Affairs sends information via Internet to 20 newspapers about happenings in Ocean County. Betty Jane will send BBYRA schedule to Bobbie Steele (506-5050).

Commodores Ball

The Commodores Ball is a BBYRA function!
