#### DELEGATES MEETING Bay Head Yacht Club April 20, 2002 MINUTES

Roll call was taken by Secretary Betty Jane France; all thirteen clubs were represented. A motion was made, seconded, and passed to accept the 10/6/01 minutes as written and mailed. The following correspondence was received:

## OFFICER REPORTS

#### Commodore

Commodore Patti Applegate reported that the Executive Committee met 1130, 4/20/02.

Proposed changes to the 2002 BBYRA Sailing Instructions and Racing Rules were reviewed.

Adjustment of the 2002 budget, the financial policy, and the dues structure were summarized.

The Fierer Fund was discussed. A BBYRA P. O. Box was rented.

#### Vice Commodore

Vice Commodore Mac Sayers reported that the Regatta Committee met at TRYC on 2/23/02.

#### **Rear Commodore**

Rear Commodore Jack Heacock reported that Job Gash assures him the equipment if in good order. Two new marks, replacing the old pins, and a propane cannon have been ordered.

Since double races will be held all weeks except the first and last, two 30' to 40' boats will be suitable for a starting team and a finishing team; the late entry boat will become a finish boat. The committee will consist of small efficient groups.

#### **Fleet Captain**

Fleet Captain Bill Scheyer is ordering radios, first aid kits, duffel bags, flags, etc. to equip twenty patrol boats.

A statement that NJYRA, BBYRA, SJYRA, and MAYRA, encompassing New Jersey, eastern Pennsylvania, and New York Harbor, wish to be known as Area C North was brought to Bill Ross' attention. #### OLD BUSINESS

2002 Commodores Ball

#### **Fierer Fund**

The Fierer Fund interest bearing account at Morgan Stanley has a current balance of \$20,533.17. Yearly interest is \$1,140.00. The fund will continue to be maintained by the BBYRA, not BYC. Financial need will no longer be a consideration.

BBYRA shall pay the registration fee(s) for approved application(s) for those competitors who qualify for the finals of the National Cup Events. A single registration fee is currently estimated to be approximately \$250 to \$300. The BBYRA will be reimbursed once a year from the fund.

A motion was made, seconded, and passed to approve the attached Preamble and Disbursement of Funds Proposal.

## NEW BUSINESS

#### **Proposed Changes to BBYRA Sailing Instructions for 2002**

Chairman Jim Carson explained that the schedule will be more flexible with many double races.

A new large orange conical inflatable mark will replace the old orange cylinder (pin).

"Race Committee Boat" has been changed to either "Signal Boat" or "Finish Boat".

Course 98 has been added which will be a portable mark 4 leg windward leeward with finish to leeward. The Sunfish Class has full status.

Laser Radial Open & Jr. is now Laser Radial and is a junior class.

## Proposed Changes to BBYRA Racing Rules for 2002

A motion was made, seconded, and passed approving the following changes to the Racing Rules for 2002, recommended by the Regatta Committee 2/23/02.

(New language shown in italics.)

1. Change Section A, Paragraph 3 to read, "Each year the Regatta Committee shall adopt Sailing Instructions which shall be provided to all entrants. The Regatta Committee should shall also cause

appropriate race information not contained in these Rules and required by RRS J1, "Notice of Race Contents", to be published in the Annual Regatta Schedule on the BBYRA web site prior to May 15th."

2. Add the following sentence after the first sentence of Section B, Paragraph 2, "Each Class shall be scheduled to compete at least once in each BBYRA race venue (Upper Bay, Lower Bay & Seaside Park)."

3. Change the last sentence of Section B, Paragraph 2 to read, "Those classes eligible for competition each year shall be designated by the Regatta Committee and published in the Annual Regatta Schedule on the BBYRA web site prior to May 15th."

4. Change Section F, Paragraph 2 to read, "No new class shall be added to the race program for championship purposes after the issuance of the Annual Regatta Schedule schedule is posted on the official BBYRA web site."

5. Change the second sentence of Section F, Paragraph 4 to read, "All scores shall be considered final eight days after they are posted on the official notice board *BBYRA web site* except that they shall be considered final at 0830 on the day of the final regatta and unless a decision on a valid protest or appeal is pending."

6. Add BBYRA web site, <u>www.bbyra.org</u>.

#### Financial Policy

All funds will be disbursed through purchase orders.

Financial statements will include both income and expense statements.

All funds given to the BBYRA will be unrestricted.

#### **Dues Structure**

Keeping or dispensing with \$200 dues of Active Member Clubs was discussed.

Consensus was to keep the \$200 fee.

## **BBYRA Yearbook**

Jim Carson reported that the yearbook will soon go to press. Clubs have been slow returning required information.

At 1445, a motion was made, seconded, and approved to adjourn.

#### Edward W. Feirer Memorial Fund

The Edward W. Feirer Memorial Fund (Feirer Fund) was created by the family of Ed Feirer. Mr. Feirer was an avid sailor, active in the BBYRA for many years, and a long time member of Beachwood Yacht Club (BYC). The purpose of the Feirer Fund is to enable skippers "to pursue further competition beyond the BBYRA level" in US Sailing National Cup Events. As per the Deed of Gift, the Feirer Fund is to be placed in a separate interest bearing account of the BBYRA and maintained by the BBYRA. The interest of this separate account are the funds to be disbursed annually to qualified skippers. Any portion of the available funds that are not disbursed are to revert to the principal of the Feirer Fund. The distribution of the available funds is to be at the sole discretion of a committee consisting of a representative member of BYC, BBYRA Commodore and BBYRA Chairperson of US Sailing National Cup Events.

#### Edward W. Feirer Memorial Fund Disbursement of Funds

- 1. All eligible registration forms submitted to the BBYRA Chairperson of US Sailing National Cup Events and approved by the Chairperson shall be considered an application to the Feirer Fund. The BBYRA Chairperson shall notify and forward a copy of each accepted application to the BBYRA Commodore and BYC Commodore simultaneously.
- 2. BBYRA shall pay the registration fee(s) for approved application(s) for those competitors who qualify for the finals of the National Cup Events from the BBYRA operating fund in consultation with BBYRA Commodore and BYC Commodore (or their designee). Disbursement is limited to posted registration fee.
- 3. The BBYRA Commodore, BYC Commodore and BBYRA Chairperson of US Sailing National Cup Events shall meet in September of each year to review the disbursements for the Feirer Fund and the performance of the Feirer Fund. BBYRA to be reimbursed for disbursement(s) made for posted registrations fee(s) for National Cup Events up to the maximum interest earned. In the event BBYRA disbursements exceed the annual interest of the Fereir Fund for posted registration fee(s) for National Cup Events, BBYRA will be reimbursed from the Feirer Fund as future funds become available.
- 4. Any funds that are not disbursed shall revert to the Feirer Fund principal.

#### Edward W. Feirer Memorial Fund

The Edward W. Feirer Memorial Fund (Feirer Fund) was created by the family of Ed Feirer. Mr. Feirer was an avid sailor, active in the BBYRA for many years, and a long time member of Beachwood Yacht Club (BYC). The purpose of the Feirer Fund is to enable skippers "to pursue further competition beyond the BBYRA level" in US Sailing National Cup Events. As per the Deed of Gift, the Feirer Fund is to be placed in a separate interest bearing account of the BBYRA and maintained by the BBYRA. The interest of this separate account are the funds to be disbursed annually to qualified skippers. Any portion of the available funds that are not disbursed are to revert to the principal of the Feirer Fund. The distribution of the available funds is to be at the sole discretion of a committee consisting of a representative member of BYC, BBYRA Commodore and BBYRA Chairperson of US Sailing National Cup Events.

#### Edward W. Feirer Memorial Fund Disbursement of Funds

- 1. All eligible registration forms submitted to the BBYRA Chairperson of US Sailing National Cup Events and approved by the Chairperson shall be considered an application to the Feirer Fund. The BBYRA Chairperson shall notify and forward a copy of each accepted application to the BBYRA Commodore and BYC Commodore simultaneously.
- BBYRA shall pay the registration fee(s) for approved application(s) for those competitors who qualify for the finals of the National Cup Events from the BBYRA operating fund in consultation with BBYRA Commodore and BYC Commodore (or their designee). Disbursement is limited to posted registration fee.
- 3. The BBYRA Commodore, BYC Commodore and BBYRA Chairperson of US Sailing National Cup Events shall meet in September of each year to review the disbursements for the Feirer Fund and the performance of the Feirer Fund. BBYRA to be reimbursed for disbursement(s) made for posted registrations fee(s) for National Cup Events up to the maximum interest earned. In the event BBYRA disbursements exceed the annual interest of the Fereir Fund for posted registration fee(s) for National Cup Events, BBYRA will be reimbursed from the Feirer Fund as future funds become available.
- 4. Any funds that are not disbursed shall revert to the Feirer Fund principal.

#### **PROPOSED CHANGES, RACING RULES OF THE BBYRA**

Recommended by the Regatta Committee, 2/23/02 (New language shown in italics.)

Change Section A, Paragraph 3.to read, "Each year the Regatta Committee shall adopt Sailing Instructions which shall be provided to all entrants. The Regatta Committee should-shall also cause appropriate race information not contained in these Rules and required by RRS J1, "Notice of Race Contents", to be published in the Annual Regatta Schedule on the BBYRA website prior to May 15th."

Add the following sentence after the first sentence of Section B, Paragraph 2, "Each Class shall be scheduled to compete at least once in each BBYRA race venue (Upper Bay, Lower Bay & Seaside Park)."

Change the last sentence of Section B, Paragraph 2. to read, "Those classes eligible for competition each year shall be designated by the Regatta Committee and published in the Annual Regatta Schedule on the BBYRA website prior to May 15<sup>th</sup>."

Change Section F, Paragraph 2. to read, "No new class shall be added to the race program for championship purposes after the issuance of the Annual Regatta Schedule is posted on the official BBYRA website."

Change the second sentence of Section F, Paragraph 4 to read,"All scores shall be considered final eight days after they are posted on the official notice-board *BBYRA website* except that they shall be considered final at 0830 on the day of the final regatta and unless a decision on a valid protest or appeal is pending."


