DELEGATES MEETING

April 8, 2006, 1330 hrs. **Bay Head Yacht Club**

MINUTES

The meeting was called to order by Commodore William Scheyer at 1350 hrs.

Roll Call by Secretary Betty Jane France indicated that all clubs were represented.

The Minutes of the October 1, 2005 Delegates Meeting were approved as mailed. Approval was received to e-mail future minutes.

FINANCIAL REPORT

A revised "2005 Operating Budget vs. Actual To Date and 2006 Proposed Budget" reflecting adjustments made since 10/1/05 was distributed and approved. Treasurer Bill Warner sent a report that all taxes have been filed and all charitable status paper work has also been filed.

OFFICER REPORTS:

EXECUTIVE COMMITTEE

Commodore William Scheyer reported the following:

The 2006 Registration Form has the following "Survey Information" with check boxes: "Add me to the BBYRA event e-mail list" and

"Send me e-mail from people interested in crewing"

Since BBYRA will not release names of club members for mailing lists, this will help us keep our sailors informed about events in our area.

Disposal of original BBYRA trailer, as approved by the Executive Committee, was solved when Roy Wilkins accepted it for the OCC Sailing Team. A motion was made, seconded, and passed donating the old trailer to the OCC Sailing Team.

BBYRA BYLAWS REQUIRE THAT ACTIONS TAKEN BY THE EXECUTIVE COMMITTEE SHALL BE RATIFIED BY THE DELEGATES. THE EXECUTIVE COMMITTEE TOOK THE FOLLOWING ACTIONS AT THEIR MORNING MEETING AND THE DELEGATES RATIFIED SAME.

1. BBYRA Bylaws -

A motion was made, seconded, and passed approving all proposed changes which updated the Bylaws to reflect current practices.

2. Trademarks, Copyrights, and Trade Name -

After much discussion about obtaining proper legal trademark protection for BBYRA's name, abbreviation, and logos, a motion was made, seconded, and passed authorizing Commodore Bill Scheyer to pursue the possibility of registering BBYRA's name, abbreviation, and logos at the state level.

3. Sponsors -

A motion was made, seconded, and passed to accept sponsorships, subject to approval by the Executive Committee, as long as BBYRA's 501 (c) (3) status is not jeopardized.

4. Feirer Fund -

The Feirer Fund currently has a worth of approximately \$20,000. The interest from this account is used to pay the posted registration fee(s) for approved application(s) for those competitors who qualify for the finals of the National Cup Events.

A motion was made, seconded, and passed to add a space on the 2007 Season Registration Form and in the 2007 yearbook for voluntary donations to the Feirer Fund. For 2006 only, revenue from fund raising events exceeding \$6800 will go into the Feirer Fund.

2007 Commodores Ball

IHYC and OCC will tentatively co-host the 2007 Commodores Ball at the college.

REGATTA COMMITTEE

Vice Commodore Bob Morrow reported that since the last Delegates Meeting on October 1, 2005, the Regatta Committee met on November 19, 2005 and again on February 25, 2006. Both meetings were well attended and productive.

The 2006 Notice of Race has been published.

A Competitors Meeting will be held on Friday, June 23, 2006 at 2015 hrs. at the Metedeconk River Yacht Club to discuss the upcoming season and highlight the significant changes for 2006. Copies of the Sailing Instructions will be available. The MCYC bar will be available following the meeting.

Proposed Amendments to Racing Rules of the BBYRA -

Section G. Protests, Disqualifications & Appeals, has been simplified and streamlined -

to not duplicate language in RRS.

to reflect the change that appeals now go to the Race Administrator Director of USSailing with copies simultaneously forwarded to the BBYRA Appeals Committee.

Appendix 1, Safety Equipment Requirement Check List -

Club 420s have been added.

A motion was made, seconded, and passed approving the Proposed Amendments to the Racing Rules of the BBYRA.

CLASS LIAISON

Rear Commodore Rich Proko sent a report stating that both Class Liaison Meetings were well attended and participation by the fleet representatives was good. Most fleets were happy with their schedules and requested very few changes.

Roy Wilkins, the fleet representative for the 420 class, expects a large fleet for this new class next summer.

EQUIPMENT

Rear Commodore Proko sent word that assistance may be needed to tow the trailer during the summer. He attached a list of equipment and proposed equipment purchases for the coming season. Most notably, the new purchases will include BEMA inflatables for the 420 course and 3 digital voice recorders.

SAFETY & TRAINING

Fleet Captain Ed Reardon announced Cardiac Pulmonary Resuscitation & Automated External Defibrillator Training on June 3, 2006 at 0900 at Lavallette Yacht Club. Reservations required.

MEASURER

Measurer Jim Carson reported that records will be updated after solicitation of all active classes for information. He was asked to address weight and other typical measurement issues with respect to the Club 420 in connection with their petition for a start on the Bay. His investigation resulted in his recommendation that we describe the boat to be used on the Bay as "Club 420 sailed in collegiate mode (spinnaker and trapeze not used)". This allows use of all 420s generally available in the area without modification in addition to those available at OCC.

BBYRA REPRESENTATIVE TO US SAILING

P/C Harry Foote attended the USSailing Meeting in Chicago.

He reported the following:

Consideration is being given to make Hawaii its own area.

There is an Area C link on BBYRA web page.

Defibrillator use is becoming popular around the country making BBYRA a pioneer.

A bill is proposed in New Jersey requiring those up to 15 years of age to wear a life jacket.

Many NJ Boating Safety Courses are being offered.

VICE COMMODORE'S REPORT

Delegates' Meeting Bay Head Yacht Club April 8, 2006

Since the last Delegates' Meeting on October 1, 2005, the Regatta Committee met on November 19, 2005 and again on February 25, 2005. Both meetings were well attended and productive.

At those meetings committee reports were received, discussed and acted upon. The committees submitting reports included:

The reports submitted, discussed and acted upon, included such items as, but were not limited to:

- 1. Allotment of racing dates.
- 2. Approval of proposed schedule of races* (copy attached).
- 3. Procedures for seasonal registration.
- 4. Proposal and approval of the 2006 Notice of Race (copy attached)
- 5. Proposal and approval of 2006 Sailing Instructions.
- 6. Proposed revisions to the BBYRA Racing Rules (copies attached).
- 7. Continuation of the Women's Division of the Laser Radial Class as a provisional class.
- 8. Introduction of the 420 Class sailed in collegiate mode (no trapeze or spinnaker) as a provisional class.

(* Prior to 3/15/06 as required under the By-Laws)

Proposed revisions to the BBYRA Racing Rules

(1) The Regatta Committee is recommending changes to the BBYRA Racing Rules, **Section G: Protests, Disqualifications and Appeals**. A copy of the proposed new Section G is attached to this report.

Rationale

This recommendation is being made to simplify and streamline the Appeals process by removing wording in Section G which merely restates the wording of the Racing Rules of Sailing (RRS). The appeals procedure is governed by the current Racing Rules of Sailing (RRS) and merely restating the wording of the RRS language is cumbersome and redundant.

(2) The Regatta Committee is also recommending a small addition to the BBYRA Racing Rules, *Appendix 1: Safety Equipment Requirement Check List*. A copy of the proposed new Appendix 1 is attached to this report.

Rationale

This addition to the Safety Equipment Requirement Check List is necessary due to the addition of the Club 420 as a provisional class.

These recommended changes have been submitted to the Executive Committee for review and approval and assuming said approval are presented to the Delegates for final action.

I wish to take the opportunity to thank all the members of all the committees mentioned above for the generous donation of their time and talent in preparing for the 2006 season and furthering our long and proud tradition of sailing and racing on Barnegat Bay.

BARNEGAT BAY CHAMPIONSHIP SERIES 2006 NOTICE OF RACE

Organizing Authority: Barnegat Bay Yacht Racing Association (BBYRA)

Rules: All races will be governed by the rules as defined in the current Racing Rules of Sailing (RRS) and <u>Racing Rules</u> of the BBYRA.

Fleets and Eligibility: A Cat, E Sloop (AM and PM), Ensign, Flying Scot, M Sloop, Full Rig Laser, Laser Radial Junior, Laser Radial Adult Women, Lightning, Sandpiper, Marshall Sanderling 18 ft. (B Cat), Sneakbox, Sunfish (AM and PM), Club 420 sailed in collegiate mode (spinnaker and trapeze **not** used). All skippers must comply with Section B of the Racing Rules of the BBYRA.

Registration: Boats may register for the season and optional lunches by mail before June 15, 2006 upon payment of the applicable pre-season registration fee. After June 15, 2006 boats may register for the season, until 34% of those races scheduled for a boat's class have been sailed, on forms available at the Regatta Headquarters upon payment of the applicable season registration fee. Daily race registration may be made on forms available each race day at the Regatta Headquarters or on the water at a "Late Entry" boat. Season Registration Forms and Registration Instructions will be available no later than May 15, 2006 on the web (www.bbyra.org), and each race day at the Regatta Headquarters until 34% of those races scheduled for a boat's class have been sailed. Sailing Instructions will be available no later than May 15, 2006 on the web, and each race day at the Regatta Headquarters and on the water at a "Late Entry" boat. After June 15, 2006 arrangements for lunches must be made directly with the host club(s).

Sailing Schedule: The first warning signal in the morning is at 0920. Afternoon races have a first warning at 1330. See the attached schedule for each fleet's sailing dates.

Safety: All boats must carry equipment as specified by their class rules, the U.S.C.G and such additional equipment as is specified in Appendix 1 to the Racing Rules of the BBYRA.

Qualification and Scoring: Scoring will be in accordance with the Racing Rules of the BBYRA Section E. To qualify for the Championship a boat must compete in at least 50% of **those** races scheduled for her class.

Laser Radial Junior: An Entrant is eligible if his/her 19th birthday will not have been reached by the last day of the calendar year.

Club 420: The Club 420 will be sailed in collegiate mode, i.e., spinnaker and trapeze may **not** be used. There will be no age limitations on skipper or crew. The 420 fleet will compete on a separate racing venue that may or may not be in the vicinity of all other fleets competing.

Prizes: Daily and season championship awards will be presented according to the Racing Rules of the BBYRA Section F. The host clubs provide additional trophies as listed in the Club Trophies List.

Proposed Amendments to Racing Rules of the BBYRA (3/24/06) (New wording in red: deletions strikethrough)

G. PROTESTS, DISQUALIFICATIONS & APPEALS

- 1. <u>Appeals.</u> Protests and Hearings shall be in accordance with the current Racing Rules of Sailing (RRS) and current US SAILING Prescriptions and procedures, of the United States Sailing Association except as modified herein. in the Sailing Instructions.

 2. All decisions upon protests and redress of the protest committee shall be in writing and filed with the applicable Scorer along with the original protest papers. The applicable Scorer, after noting any adjustments to the scores of the boat(s) involved, shall forward the original protest, the protest committee's decision, and all other, pertinent papers to the Secretary of the BBYRA Association who shall keep them on file for a period of two years.
- -3. Any "party" to a protest hearing or a hearing that resulted from a request for redress, er their representative, or the Race Committee may appeal a decision of the protest committee by filing a written appeal, postmarked within fifteen (15) days following receipt of the written decision of the protest committee. Simultaneously, the appellant shall also be sent to the other "interested parties" from the eriginal hearing.
- 4. The 3. Appeals shall comply with Appendix F (RRS) all conditions herein and provide all required information outlined in the BBYRA APPELLATE PROCEDURE and be mailed to: RACE ADMINISTRATOR DIRECTOR, US SAILING, PO BOX 1260, PORTSMOUTH, RHODE ISLAND, 02871. A complete copy of the appeal shall also be simultaneously forwarded to: the BBYRA APPEALS COMMITTEE, P.O. Box 4327, Brick, NJ, 08723.
- 5. The appeals committee of the BBYRA may: (1) order the applicable protest to be re-heard; (2) affirm the findings of the protest committee; (3) overturn the findings of the -protest committee.
 - -6. Decisions of the Appeals Committee shall be in writing and the grounds of each --decision shall be specified therein. Copies thereof shall be sent to all interested parties.-
- 7. 4. The BBYRA Appeals Committee prescribes that a BBYRA member submitting anappeal shall include a payment of \$25.00. the following fees be included with the initial filing of an appeal when mailed to the BBYRA APPEALS COMMITTEE: BBYRA members \$25.00, non-BBYRA members \$50.00.



Classes: Laser Full Rig & Sunfish.

Rules: The regatta will be governed by the rules as defined in the 2005 – 2008 Racing Rules of Sailing (RRS), the prescriptions of the United States Sailing Association, and by the rules of the International Laser Class Association (ILCA) except as modified herein, or by the rules of the International Sunfish Class Association (ISCA). RRS Appendix "P" shall apply to the Laser Class.

ILCA rules are modified so that membership in the Class is not required for this event; the first sentence of ILCA rule 7(a) is deleted; and a compass may be taped to the deck.

Racing rule A2 will be changed for scoring of the O' Day elimination as follows: A boat's score is the total of all her scores. Racing rule A4 will be changed as follows: A boat starting later than two (2) minutes after her starting signal will be scored Did Not Start. Racing rule 28.1 will be changed as follows: Except at a gate, boats shall pass between the race committee boat signaling the change of course and the nearby mark. Racing rule 33 (a) (2) will be changed as follows: The race committee will display a green rectangular board if the direction is changed to starboard or a red rectangular board if the direction is changed to port. Racing rules 35 and A4 will be changed as follows: Boats failing to finish within ten (10) minutes after the first boat sails the course and finishes will be scored Did Not Finish. Racing rule 40.1 will be changed as follows: All competitors shall wear, while on the water, other than for brief periods while adding or removing clothing, a U.S. Coast Guard approved PFD. Racing rule 44.3 will be changed to additionally provide that protests involving a rule of part 2 are subject to mandatory arbitration prior to a hearing in which case the Scoring penalty shall be 40% as calculated in RRS 44.3. Racing rule 44.3(c) is further modified to calculate any applicable scoring penalty based upon the number of boats starting the applicable race. In the O' Day elimination Racing Rule A8 is changed as follows: Ties which affect advancement to a succeeding level shall be decided by a single sail-off race between tied entries. The winner will advance to the next level. If the protest committee decides that conditions will not permit a sail-off race, the tie will be decided in favor of the entry that beat the other(s) in the last completed race of the event. These changes will appear in full in the sailing instructions.

Advertising: Advertising in the Laser Class will conform to Category C as stated in ISAF Regulation 20. Advertising in the Sunfish Class will conform to Category A as stated in ISAF Regulation 20.

Event Format: Bring and sail your own boat.

Helmsperson, Alternates, Substitutes: The helmsperson of an advancing entry in the O' Day elimination must remain the same at all levels.

Eligibility:

Except for the O' Day elimination, all entrants must comply with RRS 75, 75.1, & 75.2, and provide a copy of any of the following documents along with their registration form: a current US Sailing membership card, proof of membership in a club or other organization that is affiliated with US Sailing, or proof the entrant is competing on behalf of a club or other organization that is affiliated with US Sailing.

O' Day Elimination: ALL competitors MUST BE:

- A. At least age 16 in the calendar year of 2006; and
- B. Members of US SAILING; and
- C. A member of one of the following:
- 1) A Sailing Club or Sailing Organization (SC/SO), or Laser Class Association, belonging to a Sailing Association (SA) recognized by US SAILING;
- 2) A Sailing Club, Sailing Organization, or Laser Class Association, belonging directly to US SAILING,
- 3) A Community Sailing Program (CSP) which is a member of the local SA;
- 4) A member of or a drilling Reservist of the Military Service.

Report to BBYR 2006 US SAILING National Sailing Symposium Long Beach, CA

Jan. 18 Registration and Welcome reception

Jan. 19

We started the day at 8:30 am with a Morning meeting for all tracks. This meeting was conducted by Nan Walker who welcomed us all and explained the goals of the symposium and how the days would work out.

The Keynote speaker was Jim Gladstone who explained the twin brigantine program that they have at the LA Maritime Instate. This is a tall ship program that gets kids to work in teams as they learn about sailing the responsibilities of teamwork.

The next speaker was Kim Hapgood who explained some of the new programs at US SAILING and spoke about the resources and training that was available to staff and instructors of sailing programs.

At this point we all went to breakout sessions. I chose to attend the session "East meets West "Directors and owners of Adult programs. While this was directed at running adult programs some of the same principles can be used in junior programs. The importance of keeping students motivated and not making the students feel that they had to leave the program because they were not learning at the speed of some of the quicker learners. Next I moved on to "Getting your athletes recruited, what college coaches look for and expect" One of the instructors was Adam Werblow, Adam is the head coach at St. Mary's College. He is considered one of the countries top Team race coaches and has offered to help BBRYA and NJYRA start to develop a team racing program. One of the items stressed was that the kids need to have a team spirit and a willingness to follow the teams direction. They need to be well rounded and mannered. The sailing program is not all about how great of a sailor that you are but you also you need to be a well rounded student not just a supper star on the race course.

After a networking lunch we broke out to the afternoon sessions. I attended the "how to start a windsurfing program" run by Carolyn Borsema and Nevin Sayre. They showed how in a short time they could take a non sailor and have them board sailing on their own. This seemed like a great way to add fun to the junior program and get more kids involved that just having them spend all day in the Opti program.

Friday Morning started with an overview of the day's events by Nan Walker and then US SAILING awards presentations by Rich Jepsen. The Morning Keynote speaker was Mike Leneman speaking on "Weather and waves" Mike is a great speaker and presented us with an informative program showing us how shape and timing of waves can give us insight on what wind is to follow. This was by far one of the best presentations of the weekend and would recommend it to anyone who has a chance to hear Mike speak.

We traveled to the Ocean County College Newport Sea Base to hear about "The next generation of High School Sailing" The afternoon sessions consisted of Starting a High School program, Crew overboard trials, Communications "radio use, interfacing with your EMS" and fundraising. These were very informative sessions and it was great to see how a college could open up its facilities and help develop a true "Community Sailing program". We ten traveled to the US Sailing Center in Long Beach. To hear and see "What's Hot in dinghies, windsurfing demos – teach windsurfing in one hour, how to maintain and fix your powerboats and a great classroom and on-water team racing demonstration by Adam Werblow". Adam spoke about how excited the kids get with team racing and how much it helps to teach the team spirit. Afternoon sessions went on here and at Cal State University of Long Beach. Friday evening we moved to the Alamitos Bay Yacht Club for awards presentation and Community Sailing Awards by David Lumian and US SAILING President Janet Baxter.

Saturday Morning started with a Groups session and overview of the day's sessions by Nan Walker. The keynote speaker was Tim Herzog a "Sports psychology for parents, teachers and directors to keep sailors sailing" From this meeting we moved into the morning workshops, Hiring staff "secrets to success", Umpire clinic, Keeping the better half in sailing and the care an feeding of volunteers. These sessions were filled with interesting ideas and solutions to common problems with running a sailing program. After Lunch there was a general meeting and awards presentation then a brief overview of the afternoon sessions. The topics covered were how to expand your program using your current workforce, Marine insurance, and agent and lawyers view and a good junior instructor panel. Concluding the afternoon session was another general session and community council awards presentation the Keynote speaker "Dawn Riley".

The foregoing costs only include the costs involved in the preparation and filing of the applications, however, these costs do not include future prosecution charges and amendments, printing and issue fees, foreign expenses, etc.

Approximately, 50% of all trademark applications go through the process relatively smoothly and experience an additional \$500-600 worth of charges. These charges may include responding to informality issues raised by an Examiner, reporting filing particulars, publication dates, forwarding the certificate of registration, etc. The remaining 50% of applications run into one kind of permitteness, publication that varies from the simple and inexpensive to resolve to the impossible to resolve. For example, if we receive an initial rejection from the U.S. Trademark Office based on likelihood of confusion and/or descriptiveness, our response to this rejection would be billed at the attorney's hourly rate (ranging from \$180/hr to \$390/hr) depending on the time involved in researching case law and preparing a response, the costs could be anywhere from \$500-1500 per application. In addition, if the application is based upon intent-to-use (ITU) as opposed to prior interstate commerce, then there will be an additional charge of at least \$600-700 per class down the road to cover the filing of late specimens and at least one extension of time.

It is difficult to estimate the time it takes for a trademark application to proceed to registration. There is the possibility that an Examiner may issue an Office Action rejection against the mark or, if the mark is allowed for publication, the possibility of a third party opposing registration of the mark. However, should the mark proceed through the application process with no rejections or oppositions, it is possible to obtain registration within one year of the date of filing. However, we estimate that the average time from filing to obtaining a registration is about 15-18 months.

In summary, the approximate total cost involved in ultimately obtaining a federal trademark registration for one trademark is \$2500-4500. It is possible that this estimate could be higher if we run into major problems with the U.S. Trademark Office. Major problems include oppositions by third parties or receiving a final Action in which an appeal would need to be filed with the Trademark Trial and Appeal Board. Estimated costs in an opposition proceeding can run upwards of \$50,000. This cost would be significantly lower if settlement is reached prior to discovery or trial.
