## MINUTES

Commodore William E. Scheyer welcomed all and turned the meeting over to Vice Commodore Robert Morrow who thanked the Toms River Yacht Club for hosting our meeting. Roll call by Secretary Betty Jane France indicated that all member clubs were represented with the

Minutes of the November 11, 2006 Regatta Committee Meeting were approved as emailed.

## OFFICER AND COMMITTEE REPORTS

SAFETY/TRAINING

Fleet Captain Edwin Reardon reported that CPR/ADF Training will be held at LYC on June 2, 2007 at 0900 hrs.

He will purchase four or five new radios.

USSailing training sessions will be on BBYRA webpage.

#### MEASURER

Measurer James Carson reported that the BBYRA Measurer is charged with maintaining a copy of each class's current scantlings. Records are updated each spring after solicitation of all active classes for updated information.

The 420 Class asked that they not be required to carry a paddle. After checking Class Rules, Jim recommended this request be granted and Appendix 1 of BBYRA Racing Rules be amended. Most problems are solved within each fleet.

#### SAILING INSTRUCTIONS COMMITTEE

Chairman Jim Carson reported that this has been a challenging winter for the Sailing Instructions Committee. He thanked Vice Commodore Bob Morrow and committee members Roger Brown, Peter Chance, Dave Magno, Del Kusma, Rich Kerdock, and June Kingman. Special mention went to Rich and June for their work on the Q Course.

It is the responsibility of the Committee to update and publish the Sailing Instructions and to assist the Class Liaison Committee and the Vice Commodore.

The committee dealt with Class and Committee requests including the following:

The Sailing Schedule

Proposed Changes in the Racing Rules of the BBYRA to -

Consolidate the Lower Bay and Seaside Park venues.

"Each class shall be scheduled to compete at least once in each BBYRA race venue (Upper Bay & Lower Bay)."

Provide for obtaining and filing Protest Forms on line.

Protests must be submitted by 2000 hrs on the day of the race in question, in person or electronically, except last day when protest time limit shall be 1 hour from the time the Signal Boat docks.

The time limit for any redress filings on the last scheduled day shall be the protest time limit.

Protests will be heard at Regatta Headquarters commencing at 0700 hrs on

the next scheduled race day or at a location and time agreed upon by the protest committee and interested parties except the last day when protests will be heard immediately following the races.

Provide that Website is Official Notice Board for the Protest Committee. Delete requirement that 420s carry a paddle.

The committee dealt with changes in the Sailing Instructions including the following:

Adoption of a new Q Course Addendum to accommodate -

Additional Classes -

Laser Radial and AM Sunfish in addition to Club 420.

New Venues -

The Upper Bay sailing area will be in the vicinity of the LYC.

The Lower Bay sailing area will be in the vicinity of the TRYC. Use of an additional course (modified "N")

Unlimited number of races within a fixed time limit -

9:20 AM warning

No warning after 11:30 AM

Unique Scoring System -

On each scheduled race day, multiple races will be scored as a short series. No races will be excluded.

On each scheduled race day a boat's placement in the short series will be used for daily awards and BBYRA Championship Series scoring. Season drops - no change.

Minor changes to conform more closely to ISAF. Red flag rule same as ISAF.

Disposition of Class/Committee Requests

Sanderling request for an earlier start was considered not practical given the prevailing conditions on Barnegat Bay. Also, most Sanderlings are from Upper Bay and they have no double races on the Lower Bay.

The following were included in new Q Course Plans:

420 request for an earlier start.

420 request for more races per day

Use of Q Course by other classes

Increase # of races per day on the Q Course

420 request not to be required to schedule race(s) at SPYC.

Deletion of paddle from required 420 equipment. Not needed as boat can be driven by kinetics.

Cut off registration before date required by current Rules. No need.

Change rule for qualification ("races completed" instead of "races scheduled")

Not justified inasmuch as rules for qualification are already liberal.

Also improved race management actions will be taken to avoid abandoned races. Schedule Make-Up Races. Deemed impractical.

#### APPEALS

Chairman Chris Petracco had no official report.

He would be willing to run a seminar dealing with how protests are filed and how protest committees are run (an abbreviated Protest Committee Introduction).

#### PROTEST

Chairman Tom Sollas reported that the Protest Committee Secretary June Kingman will sent yearbook information to yearbook cochairmen.

#### SCORING

Assistant Scorer John Heacock reported that Q Course changes will be made to the scoring program.

He urged Regatta Committee members to call in scores promptly.

#### CLASS ELIGIBILITY

Chairman James Maida thanked his committee James Carson, Greg Parmele, Peter Sayia, Sam Starkey, and Ed Vienckowski.

Junior Sunfish have been approved by the Class Eligibility Committee as a Provisional Class for 2007. AM Sunfish will sail as one fleet. Twenty-two to twenty-four boats, including nine juniors, are expected on the race course.

A motion was made, seconded and passed approving Junior Sunfish as a Provisional Class to sail with the adults on the Q Course.

Entrants are eligible if their 18th birthday will not have been reached by the last day of the calendar year. (Targeted age group is 13-17 year olds sailing on high school teams.)

Chairman Maida recommends the following:

That the class liaison provides trophies.

That there be a January 15th cutoff date for requests for consideration as a Provisional Class. Chairman Maida will take care of the wording and Ed Vienckowski will present a proposal to the Executive Committee and Delegates.

Suggestions were also made to -

Require early Season Registration by a specified number of contestants in class requesting Provisional status.

Give weekly flags.

It was emphasized that the Class Eligibility Committee is not responsible for marketing classes.

USSAILING NATIONAL CUP EVENTS No report.

#### YRA REPRESENTATIVE TO USSAILING

P/C Harry Foote said the President of USSailing is from Area C as are many Judges. Only 9% of national membership voted last fall; attendance at meetings is declining.

#### OLD BUSINESS

**BBYRA COMMODORES BALL** 

This year the Commodores Ball will be held on June 9 at IHYC, hosted by IHYC and OCC.

#### **BBYRA YEARBOOK**

Cochairmen Jim Carson and Betty Jane France have been to printer Urner Barry to formulate plans for the 2007 book.

Since it appears that more information will be in the book, more advertising is needed to help cover the cost.

April 1 is the absolute deadline for information and ads.

#### **BBYRA WEBSITE**

Webmaster Jack Heacock explained that reorganization is taking place to make our website more standard compliant.

Jack welcomes regatta information; there are links to member club websites.

The extensive archives have pictures and information about BBYRA, club, and fleet trophies plus old scores.

The Toms River Seaport Society Museum has provided a fireproof filing cabinet for storage of our archives.

Commodore Scheyer complimented Jack for a job extremely well done.

## NEW BUSINESS

CHAMPIONSHIP OF BBYRA CHAMPIONS

The Championship of BBYRA Champions will be held on June 16, 2007 at TRYC.

The five race regatta will be sailed in Tech Dinghies skippered by 2006 BBYRA Champions.

Skippers can contact Will Demand if they care to practice in a Teach Dinghy.

The winner will receive a keeper trophy and two championship flags - one to keep and one to present to his/her club.

If successful, Commodore Scheyer will request, at the October meetings, for it to become an annual event.

## **REGISTRATION PROCEDURES**

Registrar Eileen King reported.

Information letters and 2007 registration forms will be mailed to 2006 sailors. Fees have been increased slightly because of fleet requests for improved trophies. Preseason Registration by mail must be received on or before June 15, 2007. Entrants may order lunch when they register by mail on or before June 15, 2007. Entrants are urged to complete forms by computer for the sake of legibility. Season Registration will not be accepted "on the water".

#### NOTICE OF RACE

Vice Commodore Morrow explained changes in the 2007 Notice of Race.

(See Sailing Instructions Committee Report for changes.)

A flotation issue was referred to the Sailing Instructions Committee.

Zone vs. fleet patrol boat issues were discussed with the general feeling being that zone is advisable for portable mark courses (regular and Q Course) and fleet for barrel courses.

## SAILING INSTRUCTIONS

A motion was made and seconded to accept the proposed changes in the 2007 Sailing Instructions. A motion was made, seconded, and passed (1 opposed) to amend the motion, subject to approval by the Sailing Instructions Committee, to include notification to the Race Committee of intention to protest.

## **RACING RULES**

A motion was made, seconded, and passed to accept the proposed changes in the 2007 Racing Rules.

JUNIOR SAILING Chairman Sue Oksen-Periera is looking for a host for the Midget Eliminations.

A motion was made, seconded, and passed to adjourn the meeting at 1210 hrs.

Change the second sentence of Article B, Paragraph 2 to read: "Each class shall be scheduled to compete at least once in each BBYRA venue (Upper Bay, <u>&</u> Lower Bay & Seaside Park).

Each class shall be scheduled to compete at least once in each BBYRA race venue (Upper Bay & Lower Bay).

Change Article G. as follows:

## G. PROTESTS, <u>REQUESTS FOR REDRESS, APPEALS AND HEARINGS</u> DISQUALIFICATIONS & APPEALS

1. Appeals, <u>**Requests for Redress**</u>, Protests and Hearings shall be in accordance with the *current* Racing Rules of Sailing (RRS) and current US SAILING Prescriptions and procedures except as modified herein.

## <u>2. The BBYRA Website and the appropriately designated pages shall serve</u> as the official Notice Board of the Protest Committee.

<u>3.</u> All decisions <u>of the Protest Committee</u> upon protest and redress shall be in writing and filed with the applicable Scorer along with the original protest papers. The applicable Scorer, after noting any adjustments to the scores of the boat(s) involved, shall forward the original protest, the protest committee's decision and all other pertinent papers to the Secretary of the BBYRA, who shall keep them on file for a period of two years.

Renumber paragraphs 3 & 4 as 4 & 5.

## G. PROTESTS, REQUESTS FOR REDRESS, APPEALS AND HEARINGS

1. Appeals, Requests for Redress, Protests and Hearings shall be in accordance with the current Racing Rules of Sailing (RRS) and current US SAILING Prescriptions and Procedures, except as modified herein.

2. The BBYRA Website and the appropriately designated pages shall serve as the official Notice Board of the Protest Committee.

3. All decisions of the Protest Committee shall be in writing and filed with the applicable Scorer along with the original protest papers. The applicable Scorer, after noting any adjustments to the scores of the boat(s) involved, shall forward the original protest, the protest committee's decision, and all pertinent papers to the Secretary of the BBYRA who shall keep them on file for a period of two years.

Delete the paddle requirement for the Club 420 in Appendix 1.

#### 13. PROTESTS

13.1 All boats intending to protest shall fly a red flag. This modifies RRS 61.1(a).

13.2 <u>13.1</u> Protests shall be written on forms available at the regatta headquarters or line, finish, or signal boat, or online at http://www.bbyra.org. Protest forms may be and lodged: within one (1) hour after the signal boat docks, with the Chairman of the Protest Committee or flag officer in accordance with RRS 61.3.

#### a) In person to the Protest Committee Chairman or Secretary, or a BBYRA Flag Officer, or

#### b) Electronically at http://www.bbyra.org

All protests whether lodged in person or electronically must be submitted by 2000 hrs on the day of the race in question, except on the last scheduled racing day when the protest time limit shall be 1 hour from the time the Signal Boat docks.

13.3 <u>13.2 Protest notices will be posted as soon as possible after the protest time limit on</u> the official Protest Committee notice board at http://www.bbyra.org. Protests will be heard at Regatta Headquarters commencing at 0730 <u>0700</u> on the next scheduled race day <u>or at a</u> <u>location and time agreed upon by the protest committee and interested parties</u> except on the last race day when protests will be heard immediately following the races.

<u>13.3 The time limit for any redress filings on the last scheduled day shall be the protest</u> <u>time limit. This modifies RRS 62.2.</u>

14. PENALTIES

14.1 The Two-Turns Penalty, RRS 44.2 will apply except that instead of two turns the penalty is one turn including one tack and one jibe. *This modifies RRS 44.2.* 

14.2 Notwithstanding paragraph 14.1, a beat <u>competitor</u> may elect to accept a Scoring Penalty, <u>as prescribed in</u> RRS 44.3.

14.3-All alternative penalties taken shall be reported to the Regatta Committee immediately after finishing.

14.4 <u>14.3</u> The penalty for Failed Inspection is DSQ without a hearing. This modifies the last sentence of RRS Appendix A5.

#### 25. CHANGE OF COURSE AFTER THE START <u>CHANGING THE NEXT LEG OF THE</u> COURSE

A change of course after the start will be <u>in accordance with RRS 33.</u>signaled before the leading boat has begun the leg, although the new mark may not be in position. Any mark to be rounded after rounding the new mark may be relocated to maintain the original course configuration. When in a subsequent change of course a new mark is replaced, it will be replaced with an original mark.

14.2 Notwithstanding paragraph 14.1, a competitor may elect to accept a Scoring Penalty, RRS 44.3.

14.3 The penalty for Failed Inspection is DSQ without a hearing. This modifies the last sentence of RRS Appendix A5.

#### 24. MARKS

Marks will be yellow inflatables. New marks, as provided in instruction 25, Change of Course after the Start, will be orange inflatables. The Initial Mark (IM) will be a large green inflatable. The short leeward mark will be a yellow inflatable with a black band.

#### 25. CHANGING THE NEXT LEG OF THE COURSE

A change of course after the start will be in accordance with RRS 33. When in a subsequent change of course a new mark is replaced, it will be replaced with an original mark.

## Proposed ADDENDUM TO THE BBYRA SAILING INSTRUCTIONS FOR CLUB 420, LASER RADIAL and AM SUNFISH

## 1. RULES

, J

- 1.1 Barnegat Bay Yacht Racing Association Sailing Instructions for 2007 apply except as modified by this Addendum.
- 1.2 RRS Appendix Q, Sound Signal Starting System will apply and when in conflict supercedes the Barnegat Bay Yacht Racing Association Sailing Instructions.
- 1.3 The Club 420 will be sailed in Collegiate Mode (no spinnaker and no trapeze).

## 2. SCHEDULE

- 2.1 On scheduled race days the first warning signal will be at 9:20 AM. Subsequent races will be started as soon as possible after the end of the previous race.
- 2.2 The Race Committee will provide as many starts as possible each day but no Warning Signal will be made after 11:30 AM.
- 2.3 The starting order will be Laser Radial, 420, Sunfish or as indicated by the Committee.

## 3. SIGNALS

3.1 All signals to competitors in the 420, Laser Radial, and AM Sunfish fleets will be made from the Start Boat.

## 4. THE COURSE

- 4.1 The 420, Laser Radial, and AM Sunfish Classes will have their own sailing areas. The Upper Bay sailing area will be in the vicinity of the Lavallette YC and the Lower Bay sailing area will be in the vicinity of the Toms River YC.
- 4.2 The course(s) will be a Triangle, Olympic or Windward-Leeward, with all marks left to port, or the "N" course (see diagram).
- 4.3 Courses may be described orally, by placard or by chalkboard.

## 5. MARKS

5.1 The turning marks of the course will be red or orange bubbles. The start and finish marks will be yellow bubbles.

## 6. THE START

6.1 The start line will be between a staff displaying an orange flag on the Start Boat at the starboard end and a yellow bubble at the port end.

## 7. THE FINISH

7.1 The finish line will be between a staff displaying and orange flag on a Finish Boat and a yellow bubble.

#### 8. CHANGE OF COURSE AFTER THE START

8.1A change of course may be given orally.

8.2 When there is a course change marks may be relocated rather than replaced prior to the first boat rounding the preceding mark.

## 9. SCORING

.....

- 9.1 On each scheduled race day, multiple races will be scored as a short series using the low point scoring system of RRS Appendix A. No scores will be excluded. One race shall constitute a race day short series.
- 9.2 On each scheduled race day a boat's placement in the short series will be used for daily awards and BBYRA Championship Series scoring.
- 9.3 For the BBYRA Championship Series a boats score will the total of her

race day scores excluding her worst scores as shown in the table below.


9.4 To qualify for the Championship a boat must compete in at least 50% of the race days scheduled for her class. (See table below).

# NOTICE OF RACE

Organizing Authority: Barnegat Bay Yacht Racing Association (BBYRA)

**1. Rules:** All races will be governed by the rules as defined in the current Racing Rules of Sailing (RRS) and <u>Racing Rules</u> of the BBYRA.

1.1 The following are the modifications to the Racing Rules which will apply to this Championship Series. RRS Part 4 Preamble and RRS 40 are changed to require that all Club 420 and single handed competitors shall wear personal buoyancy at all times while afloat. RRS 44.2 is changed as follows: The penalty shall be one turn in the same direction, including one tack and one jibe. Notwithstanding, a boat may elect to accept a Scoring Penalty (RRS 44.3). The last sentence of Appendix A5 is changed as follows: A competitor who fails to comply with SI 15.3 (Safety Inspections) will be scored DSQ without a hearing.

**1.2** In the event of a conflict between this NOR and the Sailing Instructions, the information in the Sailing Instructions shall prevail.

#### 2. Fleets and Eligibility

2.1 A Cat, E Sloop (AM and PM), Ensign, Flying Scot, M Sloop, Full Rig Laser, Laser Radial Junior, Laser Radial Adult Women, Lightning, Sandpiper, Marshall Sanderling 18 ft. (B Cat), Sneakbox, Sunfish (AM and PM), Junior Sunfish, Club 420.

2.2 All skippers must comply with Section B (Eligibility) of the Racing Rules of the BBYRA.

**2.3 Laser Radial Junior:** Entrants are eligible if their 19<sup>th</sup> birthday will not have been reached by the last day of the calendar year 2007.

2.4 Club 420: The Club 420 will be sailed in collegiate mode, i.e., spinnaker and trapeze may not be used. There are no age restrictions on skipper or crew.

**2.5 Junior Sunfish:** Entrants are eligible if their 18<sup>th</sup> birthday will not have been reached by the last day of the calendar year 2007.

#### 3. Registration:

**3.1**Boats may register for the <u>season and optional lunches</u> by mail before June 15, 2007 upon payment of the applicable pre-season registration fee. Season <u>Registration Forms</u> and Registration <u>Instructions</u> will be available no later than May 15, 2007 at the website (<u>www.bbyra.org</u>), and each race day at the Regatta Headquarters until 34% of those races scheduled for a boat's class have been sailed. **3.2**After June 15, 2007, boats may register for the season, until 34% of those races scheduled for a boat's class have been sailed, on forms available at the Regatta Headquarters upon payment of the applicable season registration fee.

3.3 After June 15, 2007, arrangements for lunches must be made directly with the host club(s).
3.4 <u>Daily race registration</u> may be made on forms available each race day at the Regatta Headquarters or on the water at a "Late Entry" boat.

**4. Sailing Instructions:** <u>Sailing Instructions</u> will be available no later than May 15, 2007 at the website, and each race day at the Regatta Headquarters and on the water at a "Late Entry" boat.

#### 5. Venue

**5.1** <u>Primary Course</u> racing area: (1) <u>Upper Bay</u> will be north of the Mathis Bridge in the vicinity of Hankins Island and Green Island area; (2) <u>Lower Bay</u> will be south of the Mathis Bridge in the vicinity of the Wanamaker and Seaside Park area. Separate Course Charts will be provided for Upper Bay, Lower Bay and Seaside Park Yacht Club race days.

**5.2** <u>Appendix Q Course</u> racing area: (1) <u>Upper Bay</u> will be in the vicinity of the Lavallette Yacht Club; (2) <u>Lower Bay</u> (to include SPYC Race Day) will be in the vicinity of Toms River Yacht Club.

#### 6. Schedule:

**6.1**The first warning signal on <u>both</u> the "Primary Course" and the "Appendix Q Course" in the morning is at 9:20AM. The first warning signal in the afternoon is at 1:30PM. See the attached schedule for each fleet's sailing dates.

**6.2** A "competitors meeting" will be held on Friday evening, June 22, 2007 at the Lavallette Yacht Club at 7PM.

7. Safety: All boats must carry equipment as specified by their class rules, the U.S.C.G and such additional equipment as is specified in Appendix #1 to the Racing Rules of the BBYRA.

#### 8. Qualification and Scoring:

**8.1** The Low Point Scoring System of RRS Appendix A will apply with the exception noted in #1.1, above. **8.2** Boats sailing the **Appendix Q Course** will sail multiple races on each scheduled race day. These multiple races will be scored as a short series using the Low Point Scoring System of RRS Appendix A. No score will be excluded. One race shall constitute a race day short series. On each scheduled race day a boat's placement in the short series will be used for daily awards and BBYRA Championship Series scoring.

8.3 Qualification and scoring will be in accordance with the Racing Rules of the BBYRA Section E.

#### 9. Radio Communications

**9.1** A boat shall neither make radio transmissions while racing nor receive radio communications, not available to all competitors. This restriction also applies to mobile telephones.

9.2 The Race Committee will monitor VHF Channel 68 and use this channel to communicate to the competitors.

9.3 Competitors may use channel 68 to communicate (a) emergencies, or (b) their intent to withdraw from a race.

**10. Prizes:** Daily and season championship awards will be presented according to the Racing Rules of the BBYRA Section F (Administrative Rules). The host clubs provide additional trophies as listed in the <u>Club Trophies List</u>.

I wish to welcome each of you to the 2007 season. This letter outlines registration information for the 2007 championship. The 2007 schedule has been tailored to accommodate the wishes of our fleets. Please note the following with regard to the registration forms and process:

- Throughout our forms and documents, the use of the word "Skipper" means "person in charge" who must be on board while racing as required by RRS 46.
- One Upper Bay and one Lower Bay Tyvek Course Sheet is included with each season registration. Extra sets of Tyvek Course Sheets may be purchased at \$4.00 per set while supplies last.
- Lunch will again be optional, but <u>must</u> be ordered before June 15, 2007.
- Provisional classes are not eligible for awards or flags.
- Improved crew awards will be awarded with trophies for applicable classes.

## How to register for the season

The registration form is available both on our website at <u>http://bbyra.org/reg\_form2007.htm</u> as well as enclosed. The registration form on our website is both dynamic and interactive. You may return the completed registration form along with your check payable to "BBYRA Season Registration" by mail postmarked on or before June 15, 2007 or you may register in person at the weekly regatta headquarters until 34% of those races scheduled for your class have been sailed.

## **2007 Registration Requirements**

Each competitor is reminded to review the 2007 BBYRA Championship Sailing Instructions, BBYRA Racing Rules, and the 2005-2008 Racing Rules of Sailing as part of their pre-race preparation. Since then, more than 450 applicants have been named US SAILING Judges, Senior Judges, and Umpires.

The Judges and Umpires Programs provide qualified judges and umpires for sailors and race organizers. A Regional Administrative Judge (RAJ) is appointed in each of US SAILING's 11 geographic areas by the Board of Directors to assist area race organizers in staffing protest committees, to oversee the screening, training and approval of candidates, and to monitor the performance of US SAILING Judges in each area. The Umpires Committee oversees the US SAILING Umpires Program.

Composition of a Protest Committee

A protest committee is a group of individuals with the responsibility to hear and decide protests and such other duties and responsibilities as has been given to them by the organizing authority under RRS 89. The desirable characteristics of a protest committee are:

- 1. The chief judge holds a US SAILING appointment;
- 2. A minimum of three members, but often five and sometimes more for principal events;
- 3. As broad a geographic representation as exists among the competitors;
- 4. No conflict of interest under RRS 63.4;
- 5. One or more members with active sailing experience in the same or similar classes, and one or more members with local knowledge.
